<b>1.0</b>	It is proposed to fill up following posts in ICF by reengaging the retired Railway employees in terms of Railway Board's letter no E (NG)-II/2007/RC-4/CORE/1 dated 16.10.2017 & 12.12.2017, subject to fulfilling the <b>Eligibility Criteria</b> and the conditions specified below.

<b>2.0</b>	<b><u>ELIGIBILITY CRITERIA:</u></b>		
<b>2.1</b>	<b>Age Limits</b>	Upto 65 years of age.	
<b>3.0</b>	<b>Scheme Validity</b>	Upto 01.12.2019	
<b>4.0</b>	<b>Only staff retired from Railway services are eligible to apply.</b>		
<b>4.1</b>	The re-engagement shall be strictly <b>upto 01.12.2019 or upto the age of 65 years</b> or till the filling up of the posts through other modes.		
<b>4.2</b>	The Administration reserves the right to terminate the services of the re-engaged retired Railway employees at any time, in case their work or conduct is found unsatisfactory or in administrative exigencies. The decision of the ICF administration is final.		
<b>4.3</b>	The employees, who were <b>Removed/Dismissed/Compulsory retired</b> as a result of disciplinary action or <b>under Age review</b> are <b>not eligible</b> for re-engagement.		
<b>4.4</b>	The employees retired under <b>SRRS/LARGESS</b> are also <b>not eligible</b> for re-engagement.		
<b>4.5</b>	Monthly remuneration of a retired employee being re-engaged will be determined by reducing Pension from his/her last pay drawn (i.e. Basic Pay + DA).		
<b>4.6</b>	The re-engaged retired Railway employee will not be eligible for any kind of leave like (CL, LAP, LHAP etc.). Absence if any, appropriate deduction will be made from the monthly remuneration.		
<b>4.7</b>	The re-engaged employees are not entitled for any other benefit or facilities except the monthly fixed remuneration.		
<b>4.8</b>	The retired employee shall execute an agreement to abide by all the terms and conditions of the re-engagement.		
<b>4.9</b>	Re-engagement shall be subject to prescribed medical fitness for the category in which they are re-engaged.		
<b>4.10</b>	Suitability / Competency of the applicant shall be adjudged by nominated committee before their re-engagement.		
<b>4.11</b>	The duty hours of the re-engaged employees would be as prescribed by competent Authority, as per the working conditions of the category with weekly off for one day.		

<b>5.0</b>	<b>How to apply</b>
<b>5.1</b>	Applications should be strictly in the prescribed format as per Annexure, shall be filled in A-4 size paper.
<b>5.2</b>	The application format is also available in the ICF website <a href="http://www.icf.indianrailways.gov.in">www.icf.indianrailways.gov.in</a> .
<b>5.3</b>	One passport size photograph should be pasted on the application form at the space specified.
<b>5.4</b>	Self-attested photocopies of the following documents should be enclosed.
	(i) Service Certificate
	(ii) Pensioner Identity Card
	(iii) Pension Payment Order (PPO).
<b>5.5</b>	The applicants should bring all the original certificates when they are called to appear for Document verification.
<b>6.0</b>	The application should be sent along with the above enclosures, duly self attested. On top of the envelope " <b>Application for Re-engagement of Retired Railway Employees</b> " should be written in Block letters and write the post applied for. It should be addressed to the <b>ASSISTANT PERSONNEL OFFICER / RECRUITMENT, INTEGRAL COACH FACTORY, CHENNAI - 600 038</b> and <b>sent by ordinary post only</b> so as to reach this office on or before the last date of receipt of applications.
