2. ESSENTIAL QUALIFICATION AND EXPERIENCE:

A First class Engineering Degree or Masters Degree in Computer Science /Electronics and Communication/ Electrical with minimum 60% marks in aggregate from any recognized Institution/University.

3. EXPERIENCE:

Minimum 03 years for BE/B. Tech applicants or 01 year for M.E/ M. Tech applicants; relevant experience in Training & Development of new projects in the respective domains as mentioned at Table-1.

4. FACULTY REMUNERATION:

The faculties will be paid on the basis of number of sessions for which their services are utilized. Each session will be for a duration of 1.5 hrs. and Rs. 300 will be paid as honorarium.
