The Trade Test will be conducted in morning session for screened – in candidates and the Written Test in afternoon session for those candidates only who qualify in the Trade Test. Accordingly, all the screened - in applicants are requested to make necessary arrangements keeping in view the COVID – 19 situation.

1. The above schedule is subject to change depending upon the COVID-19 situation and related instructions issued by the CSIR / Government of India / Government of Telangana or any other Competent Authority.
2. **The Trade Test and the Written Test will be held in Hyderabad.** No TA / DA will be paid for attending the test.
3. The Admit card to the candidates will be issued separately through e-mail.
4. The candidates are advised to plan their itinerary and arrange own accommodation, if need be, well in advance.
5. The candidate must ensure that his / her name is reflected in the list of shortlisted candidates.
6. The candidates are also advised to read carefully the advertisement (with corrigendum / addendum thereto, if any) as well as the shortlisting criteria and ensure that he / she meets all the eligibility conditions (age, educational qualification, experience, reservation & shortlisting criteria etc.).

COVID – 19 Related Instructions

1. All the candidates will have to undergo the COVID – 19 related screening at the time of reporting for the test before allowing them entry into the test venue.
2. All the candidates must have downloaded the Arogya Setu App on their mobile number mentioned in application for the post with at least past 30 days' data therein as on the date of test which is required to be shown before permission for entry inside the test venue.

The mobile has to be switched off thereafter. In case of failing to have Arogya Setu App, the candidates will be required to submit a declaration on his / her COVID 19 related status. The declaration form will be provided at the time of reporting for test.

Concealing any information or providing wrong information on self on COVID-19 related status will attract penalty, including debarment for applying for any NGRI / CSIR post(s) in future, in addition to the legal action as per Government guidelines on the matter.

3. The entry will be barred for those candidates who are found to have moderate to high symptoms of COVID 19 to avert the risk of getting other candidates / operatives infected. Entry will be restricted for those candidates who are found to have mild COVID 19 related symptom(s). Hence, the candidates attending the written test are required to rule themselves out of COVID 19 infection for ensuring their own safety as well as the safety of all participating in the Trade Test / Written Test.
4. Candidate without proper mask will not be allowed inside the test venue.
5. No companion of candidates will be allowed inside the test venue.
6. The carrying of luggage / personal belongings [other than e-admit card / photo ID proof / blue / black ball pen(s)] / any electronic gadget by the candidates inside the test venue is not allowed.
7. Social distancing norms have to be followed by the candidates while reporting and appearing for test.
